- A. Discussed status of DEQ Consent Order, engineering guidance, etc.
- B. Jacob (Bodie) Bachelor, attorney and bond counsel with Centennial Law Group in Duncan, came to discuss process for REAP Grant and CWSRF applications. We are required to have a bond counsel to be able to apply for both. He explained what is available and the processes for getting the funding and getting principal forgiveness loans. He wouldn't charge for helping with the REAP grant application which is only for \$150,000. The CWSRF will be for \$1,000,000 or more depending upon project. (Principal forgiveness is only available for \$1,000,000/year.) Attorney's fee is based upon final closing amount and not paid until the money is available to us, their fee is a contingency paid from the loan proceeds. 2 motions: Jeff made motion and Ed seconded to put the \$1,000,000 figure into the agreement for bond counsel services agreement. Jeff aye, Ed aye, Leighton aye, Bill aye, Jim aye. Motion carried. Bill moved that we sign the bond counsel agreement with Jacob Bachelor, Centennial Law Group, to service as our bond counsel in these financial applications. Jeff seconded. Jeff aye, Ed aye, Leighton aye, Bill aye, Jim aye. Motion carried.

New Business:

A. Discussed the deductibles for all our property insurances through ORWA Assurance Group. We had quotes for insurance deductibles for \$250, \$500, & \$1,000. Ed moved, Bill seconded, that we accept \$250 deductibles on each coverage. Jeff aye, Ed aye, Leighton aye, Bill aye, Jim aye. Motion carried.
